



# TRYSNES BRYGGE

## **Boat rental and cancellation conditions**

### **Payment:**

When booking our rental boats at Trysnes Brygge, the full amount must be paid at the time of booking. When the order has been received by us, the tenant will be sent a payment link from Trysnes Brygge AS. Payment from the renter is confirmation of booking the rental boat. Please note that non-payment will not be accepted as a booking.

If the amount is not paid upon receipt of the payment link, the boat will be considered available for a new rental.

### **Order/Confirmation**

The person/company the order is registered with is responsible for the entire the rental agreement and all passengers on board the boat. The customer is financially responsible for the entire the booking, including payment of the entire rental amount and any compensation for damage that may arise during the rental period. A booking is binding whether it is made in writing, by telephone, by email or verbally. The rental agreement is confirmed via a payment link from Trysnes Brygge AS.

Trysnes Brygge AS reserves the right to post-invoice any claims.

### **Cancellation/Changes**

The tenant may cancel or change the reservation no later than 14 days before the rental period for a fee of NOK 500,-. The fee is not refundable in the event of cancellation.

Bookings made later than 14 days before the rental period are binding. If cancellation/change of rental later than 14 days before arrival, the tenant is 100% financially responsible according to the rental agreement. All cancellations and changes must be made in writing via email, where account information must be provided if applicable.

The cancellation is only valid if it is confirmed by Trysnes Brygge AS.

Failure to pay is not a valid cancellation.

### **Rental information**

The rental period starts at **09:00** on the first day of rental and ends at **18:00** on the day of delivery, unless another time has been agreed or other information is provided.

### **IMPORTANT!**

**If collection will not take place on the first day of the rental period at 9:00 AM sharp, or at a later time arrival, this must be specifically agreed with the landlord.**

## **Defects or damage to the rental property**

If damage or deficiencies are discovered upon receipt of the boat, it must be reported immediately by phone +47 48994222, and photos will be taken. If the renter receives a boat that has not been cleaned, or is not delivered with a full tank, it does not automatically give the right not to do these delivery requirements.

## **Boat rental requirements (important! Read before booking)**

- **SKIPPERS MUST BE 18 YEARS OLD AND HAVE A BOAT LICENSE - PERSONS BORN BEFORE 1980 ARE EXEMPTED** FROM THE REQUIREMENT BUT MUST HAVE GOOD KNOWLEDGE OF BOATING AND SEAMANSHIP
- **LIFE JACKET IS REQUIRED** WHILE ON THE BOAT
- BOATING IN DAYLIGHT ONLY
- SKIPPERS MUST BE SAFETY FAMILIAR AND FAMILIAR WITH THE AREA BEFORE THE BOAT TRIP STARTER
- RENTAL AGREEMENT MUST BE COMPLETED AND SIGNED BEFORE RENTAL
- THE BOAT WILL BE RETURNED CLEANED AND WITH A FULL TANK OF FUEL (95 Unleaded) FILLED AT TRYSNES BAY.

NB!

IF YOU DO NOT WANT TO CLEAN THE BOAT AND/OR FILL UP THE GASOLINE, THIS SERVICE CAN BE ORDERED IN ADVANCE FOR NOK 250,- + EXPENSES FOR PETROL.
